Agenda

Brief updates and report-backs (no more than 5 minutes each)

- SacTRU meetings, September 9, 16, 23: *had Jim Boyle talk about route optimization, goal is November 1, 2018, consultant announced Oct 23; deep dive concern about campus change, RFP has gone out, Doug Carter contract, Budge asked but still passed*
- SacRT board meetings, September 11, 25: *Budge voted against campus RFP, question is whether a new campus is really need it*
- ECOS TAQCC, September 7: *Dan Leavitt spoke about San Joaquins Service, particularly new service on Sacramento division to midtown; ECOS has lawsuit on Hwy 50 expansion; Ralph asked what happened to \$7M settlement, Betsy said it is "parked", what would it take to complete Folsom double-track*

Issues

- SVS transit and transportation issues (ongoing)
 - affirm letter to city: *affirmed*
 - meeting with Greg Taylor: *defer until after Oct 16 SVS meeting*
 - Oct 16 city SVS Community Workshop: *several members will attend, discuss at next Action Team meeting*
- SacRT campus move criteria and accessibility
 - affirm statement to SacRT
 - What functions should be where? Who needs access?
 - Lynne's idea of SacRT campus at SVS
 - customer service centers
 - STAR: *admin and buses do not need to be same place; some admin needs to be at SVS, at least customer service; more than one service center, piggyback on other dispersed government centers as the county has done*
- STAR involvement in SacRT Route Optimization Study: *what outreach are they going to do, what is STAR role, how will engagement be done, we ask for assurance of outreach, there is an info sheet on ROS, which we should post, ask what phrase about bus stops means*
- STAR involvement in city Downtown Specific Plan: *no action yet, but report back from Oct 9 meeting*
- STAR letter on Green Line: *defer to next meeting*
- STAR position on Mobility Access Committee?: *no*
- STAR future meeting locations: *stay at Organize Sacramento through December*
